Our Lord has told us “to make disciples of all nations” (Matthew 28:19). We, the evangelist/pastor and members of _____, take that mandate seriously. Therefore, in order that the Lord’s directive may be carried out in our midst and through the lives of others, we make this voluntary agreement with the Department of Outreach of Lutheran Church-Canada, ABC District.

We praise God for any growth in his Church for it results from the Holy Spirit’s activity in the lives of people (1 Corinthians 3:6). We thank God for the opportunity to work together in this endeavour. We pray God will bless these plans we have made trusting in his purpose and relying on his power.

We commit ourselves to implore God to use us to:

1. Develop a congregation at _____ of sufficient size and strength to sustain an effective Christian ministry to this community, striving to reach those who do not know Christ as Saviour and Lord.
2. Provide an increasing awareness of the worldwide mission of the Church that our efforts may include reaching beyond our mission/congregation in church planting and mission support.

So that these purposes may be accomplished, we the pastor/evangelist and people of _____ Lutheran Church/Mission make the following commitments:

1. Relying on the Holy Spirit, we aim to set ambitious goals for the current year and for three and five years into the future (in writing, using the accompanying form) and strive to attain them through sound strategies and faithful training of the members of our mission/congregation in the following facets of congregational life.
 - a. Worship
 - b. Instruction
 - c. Fellowship
 - d. Evangelizing
 - e. Service
2. The pastor and leadership will review and submit to the Department an updated Covenant Agreement by **OCTOBER 15** of each year, and submit a mid-year review by **JULY 15**.

3. To complete the annual LCC Statistical report and send a copy of the ABC District office.
4. To provide our pastor and other leaders with the necessary means to lead the members of our congregation to grow: in their knowledge of God's Word, their faith in Jesus Christ, and their ability to serve in God's Kingdom;
5. To work with the following schedule of financial support from the Department of Outreach of the ABC District.

For its part the Department makes the following commitments:

1. To seek to provide the financial resources as identified above.

4. To provide feedback on reports and requests.

The Congregational Budget and Income are estimates to be made definite each year, but the Financial Support is listed as the maximum allowable each year. We will follow the established policies and procedures of the Department of Outreach in applying for this financial support each year (see *Policy and Procedure Manual*).
